I applied for campground status through the NDDH and the state application is underway. Please let me know if there's anything else you need. I'm so excited about this project, it's going to make a huge impact on the mission of our nonprofit by allowing people from farther away to come stay with us and learn about the mustangs and potentially adopt them. We already have four people coming from around the country this April to adopt mustangs . Right now we're planning on putting them up at another local campground unless we can get approval in time, which would be amazing. I'm really hopeful that with just four primitive tent sites, it won't be too difficult to get people on board .

Hi Mackensie,

You do not need a building permit if the structure is under 200 sq. ft. and there is not any electrical going to it. It must be properly secured to the ground though. You need to contact Northeast District Department of Health to see if they have any requirements (860-774-7350) and you must contact the Town of Sterling Zoning Enforcement Officer, Victoria Robison-Lewis for the Town zoning requirements.
