Hi Melissa, I got the letter regarding the permit on the dome. I'd be happy to fill out a permit if necessary, but it's a temporary event tent and not a permanent structure. There's no foundation, it's just staked into the ground. We have it set up currently but it will be moved so I'm not sure if that impacts the permitting process. I asked zoning chair if there would be any issues with this a couple of months ago and he just said that we needed to get a certificate of trade name on file with the town, which we did (although in hindsight I realize you're probably the person I should have asked!) Let me know how you'd like me to proceed or if you'd like to come out and look at it to determine the best course of action.
